Dear Exhibitor:

My family's company, Om Jai Jagdish, Inc., owns the Howard Johnson Inn in Tucson. We have been involved in a legal case with Pacifica Trade Shows about the annual gem show at the Howard Johnson. On December 26, 2008, it was decided in that case that Pacifica Trade Shows does not have the right to use the Howard Johnson for a gem show in 2009 or afterwards. Pacifica Trade Shows and AKS Gem Shows will not be at the Howard Johnson in 2009. Starting in January, 2009, Howard Johnson gem and mineral show will operate the Howard Johnson Gem and Mineral Show.

We understand that you made an agreement with Pacifica Trade Shows or AKS Gem Shows for a space at the Howard Johnson in 2009. "Howard Johnson gem and mineral show" will make the same space available to you in 2009 for the same price.

If you want your space at the Howard Johnson for the 2009 show, please do the following things no later than January 10, 2009:

1. Fill out, sign and return by fax the enclosed "Assignment of Gem Show Payments" and the "2009 Howard Johnson Gem Show Contract." If possible, the person who signed your agreement with Pacifica Trade Shows should also sign these papers.

2. List the date, amount and method (cash, credit card, check, customer checks or other) of any payments that you made to Pacifica or AKS for the 2009 show.

3. Attach copies of your contract for 2009 and any receipts, credit card slips or cancelled checks that you have to show the payments.

4, Fax the signed Assignment of Gem Show Payments and Howard Johnson Gem Show Contract, your contract with Pacifica and all receipts, cancelled checks etc. to me at 520-791-3808

We will use the Assignment of Gem Show Payments to collect your deposit from Pacifica. We look forward to seeing you at the 2009 Howard Johnson Gem and Mineral Show. We will do our best to make the show better than ever for you.
